Description:

The program's objective is to provide comprehensive support for reading in the Bredjing, Treguine, and Gaga refugee camps in eastern Chad and in the nearby Chadian host villages of Abougkni, Barde, Bakhita, Bredjing, Faguire, Fodji, Hadjer Hadid, Kadjala, Kinouane, Kodolok Koundjan, Korkoguine, Koundoubla, Lira, Louma, Mobouguine, N'gourkoudji, Rataye, and Sira. The total population to be served is approximately 69,000 Darfuris in the refugee camps and approximately 19,000 Chadians in the villages. Program goals include supplying curriculum for the refugees' English classes, providing reading glasses, constructing libraries in each of the refugee camps, providing English/Arabic and French/Arabic dictionaries, providing school supplies, providing solar lighting suitable for group reading in schools and literacy classes, completing school construction in the villages, providing mini-libraries for the villages, and supplying curriculum for French and Arabic literacy classes in the villages (details at <http://www.bookwish.org>). Due to security concerns in the vicinity of the villages, it is expected that not all villages will receive all forms of support. All support is targeted as specifically as possible based on actual needs, as determined in partnership with CORD (<http://www.cord.org.uk>), a UK-based charity managing education programs in these places as an implementing partner of UNHCR and UNICEF.

During the fiscal year covered by this report, the primary program accomplishment was the delivery of 539 textbooks from Oxford University Press' Headway English language course to the refugee camps, which has resulted in the number of refugees learning English increasing from 400 to approximately 1180. An additional measure of the success of this program is that the English students chose to continue their classes during the regular summer school break.

Secondary program accomplishments include the design of a solar lighting system appropriate for group reading within the environmental, security, logistical, and technical constraints of operation in the refugee camps and villages; and the delivery of solar lighting equipment, reading glasses, and dictionaries to Chad (see Statement 1). These delivered goods have yet to be utilized, but are in the process of being distributed locally, and we anticipate reporting on program accomplishments associated with their use in next year's form 990.

(b) Dhi Qar University

Grants and Allocations: \$4,229.30

Program Services Expenses: \$4,229.30

Description:

The program's objective is to support English language learning programs at Dhi Qar University in Nasiriyah, Iraq, especially to help students utilize modern engineering textbooks recently donated by Oregon State University. As a result of the grant of English language learning textbooks and accompanying audio described in Statement 1, two 45-day English courses for approximately 50 Iraqi government employees each have been taught at the English Language Center of Dhi Qar University, and some of the textbooks have been adopted and used as supporting material for an English department course. A secondary accomplishment is an assessment of remaining English language learning needs at Dhi Qar University, completed with the cooperation of University faculty. Most of the delivered goods have not yet been utilized, and we anticipate reporting on program accomplishments associated with their use in next year's form 990.
